

## The Community's Campaign Raises \$18 Million with United Way of Dane County

Additional \$24.6 million raised to close out a successful Centennial year, fueling the next century.

**Madison, WI (March 2, 2023)** – Thanks to more than 20,000 individuals and 500 businesses across Dane County, our community was able to raise \$18 million during our 2022 Community Fundraising Campaign. And an additional \$24.6 million was raised through our Centennial efforts!

Last night, United Way of Dane County hosted a Centennial Celebration, with nearly 900 community members joining us at the Monona Terrace. At this event, we celebrated the community's generosity – not only in 2022, but in the entirety of our 100+ year history – giving thanks to numerous partners for making real, measurable change possible in Dane County. And we officially launched into the next century!

"The community's incredible generosity is how we and our partners are able to innovate and better serve local families and individuals, together," says Renee Moe, President & CEO of United Way of Dane County. "Moving forward, we will continue to mobilize the caring power of our community to spark lasting, generational change that lifts up families across Dane County! Because we know that family well-being is community well-being. And it takes every one of us to care and act to make our community strong."

Thanks to the success of last year's campaign, United Way is empowered to fund hundreds of local nonprofits who work collaboratively in measurable, accountable ways – responding to critical needs and investing in root causes to help us all be stronger."

Giving to United Way through the community campaign amplifies impact six times or more. In fact, for every dollar that goes through us, our army of volunteers is enabled to find six more dollars through a network of caring connection – allowing us to focus on not only helping our neighbors today, but solving long-standing issues. With these dollars, we're able to support more than 550 nonprofits – including 112 local organizations and 52 local programs working to address the greatest needs in 2023.

While we were thrilled to celebrate our collective impact through the community's campaign, we also wish to extend special thanks to all those who made our Centennial year such a success. Last year, American Family Insurance generously established a Corporate Challenge Grant, pledging two \$2.5 million gifts to be matched by other corporate partners in Dane County. This gift was meant to inspire local businesses to unite in effective community change – and several companies stepped up to the plate!

Leading the way were our Centennial Champions, including American Family Insurance, TASC, Madison Gas and Electric and Exact Sciences. Also stepping up were our Centennial Partners, including CUNA Mutual Group, National Guardian Life Insurance Company, Sub-Zero Group Inc., Ascendium Education Group, BMO Harris Bank, Alliant Energy, Oscar Rennebohm Foundation and Springs Window Fashions.



This matching challenge will endow our Community Resource Hubs – including United Way 211 and our Volunteer Resource Center – to further increase our ability to innovate and be a catalyst for change for the next century. Additionally, through more than 100 generous donors, including Tocqueville Legacy Circle commitments (planned gifts of \$250,000+), an additional \$14.3 million was raised for the United Way of Dane County Foundation, bringing our Centennial total to \$24.6 million!
