DANE COUNTY POPULATION (INDIVIDUALS): 564,777¹

POVERTY

57,774 people are experiencing poverty² in Dane County (10.5% of the population).³

72% of Camp Randall could be filled with people experiencing poverty in Dane County.⁴

118,121 people in Dane County live below 200% of the federal poverty line (21.4% of the population).⁵

By Race and Ethnicity: White: 8.7%; Black or African American: 19.5%; American Indian or Alaska Native: 19.7%; Asian: 17.2%; Some Other Race: 17.6%; Two or More Races 16.0%; Hispanic or Latino: 16.4%⁶

CHILD POVERTY

2,511 children under 5 (8.6%) are experiencing poverty in Dane County.⁷

837 red wagons could be filled with children under 5 experiencing poverty in Dane County.⁸

By Race and Ethnicity: White: 3.2%; Black or African American: 33.8%; Asian: 7.3%; Some Other Race: 8.4%; Two or More Races: 19.6%; Hispanic or Latino: 21.8%⁹

UNEMPLOYMENT

2.4% of individuals 16 years or older are experiencing unemployment in Dane County.¹⁰

Unemployment among Black or African American and American Indian or Alaska Native people is significantly higher than the overall rate (at 5.4% and 12.1%, respectively).¹¹

HOMELESSNESS

737 individuals (including 123 children with 94 parents) were experiencing acute homelessness in 2024.¹²

Homelessness has increased by 18% from last year.

Black or African American people make up over 40% of those experiencing homelessness in Dane County despite composing 5.0% of the population.

HIGH SCHOOL COMPLETION

93.0% of students completed high school in Dane County (5,672 out of 6,096) (6-year cohort).¹³

By Race and Ethnicity: White: 95.7%; Black or African American: 86.7%; Asian: 97.2%; Hispanic or Latino: 89.2%; Two or More Races: 92.7%¹⁴

THIRD GRADE READING

54.9% of third grade students meet grade level standards in reading (2,810 out of 5,114)

(Note: Due to changes in test score benchmarks, this data is not comparable to previous years).¹⁵

33 school buses could be filled with third grade students who are not reading at grade level.¹⁶

By Race and Ethnicity: White: 67.4%; Black or African American: 13.4%; Asian: 63.6%; Hispanic or Latino: 27.8%; Two or More Races: 49.7%¹⁷

LOW BIRTHWEIGHT

7.1% of babies were born at low birthweight in Dane County (399 out of 5,594).¹⁸

By Race and Ethnicity: White: 6.3%; Black or African American: 15.4%; Hispanic or Latino: 7.1%; Asian (non-Hmong) or Pacific Islander/Native Hawaiian: 5.4%; Two or More Races: 9.0%¹⁹

HEALTH INSURANCE

Nearly 1 in 25 people do not have health insurance in Dane County (3.6%, or 20,341 out of 561,010).²⁰

By Race and Ethnicity: White: 2.5%; Black or African American: 6.5%; American Indian or Alaska Native: 11.4%; Asian: 3.3%; Some Other Race: 20.9%; Two or More Races: 9.0%; Hispanic or Latino: 15.2%²¹

LIFE EXPECTANCY

Life expectancy is over 10 years shorter for Black or African American people than the overall average.²²

Overall: 81.2 years. **By Race and Ethnicity:** Asian: 87.3 years; Black or African American: 71.1 years; Hispanic or Latino: 84.1 years; White: 81.6 years²³

Whenever we present data disaggregated by race and ethnicity internally or externally, it is essential that this data is properly contextualized. When we see disparities by race and ethnicity in education, income and health outcomes, we are seeing the result of systemic racism (happening at institutional, cultural and interpersonal scales), not placing blame or assuming cultural or group-based deficits.

Poverty status cannot be determined for people institutional group quarters (such as prisons or nursing homes), college dormitories, military barracks, living situations without conventional housing (and who are not in shelters). Additionally, poverty status cannot be determined for unrelated individuals under age 15 (such as foster children) because income questions are asked of people age 15 and older and, if someone is under age 15 and not living with a family member, we do not know their income. The total number of individuals for whom poverty status is calculated in Dane Co. in ACS 5-year (2019-2023) Data (Table S1701) is 551,045 people.
