Applicant Criteria

- Applicant must be a group or organization. Individuals may not apply.
- 501(c)(3) status is **NOT** required to apply.
 - However, applicant must identify a registered 501(c)(3) tax-exempt nonprofit organization to serve as their fiscal agent. <u>Note</u>: Awards can only be distributed to registered nonprofit organizations. Awards cannot and will not be distributed to individuals.
- Applicant's annual operating budget cannot exceed \$75,000.
- Applicant must have an existing relationship with the community in which services will be offered.

Program Criteria

- Program must align with at least one of the goals identified above.
- Program must exclusively serve residents of Dane County, Wisconsin.

Applications will not be considered if:

- The applicant is a person. Only organizations will be considered for funding.
- The applicant's annual budget exceeds \$75,000.
- The organization has previously been awarded a micro-investment grant for the same program.
