UW Health and Quartz for HealthConnect

At United Way, we believe everyone deserves access to quality health care, regardless of cost. Thanks to the generous support of UW Health and Quartz, we offer the HealthConnect Premium Assistance Program. Since 2014, HealthConnect has been a lifeline for Dane County residents, helping over 3,500 economically vulnerable people access more than 7,500 health insurance plans. Most participants enjoy full-year coverage, while others rely on HealthConnect as a bridge between jobs, programs like BadgerCare, or eligibility for Medicare. Remarkably, 20 enrollees have maintained continuous coverage for ten years – a true testament to the program's lasting impact. By reducing lapses and keeping our neighbors insured, HealthConnect shows how collaboration can create meaningful, lasting change in our community.
